- ii. The methods for measuring a composition or characteristic (e.g. moisture content) and for provisions where a maximum limit is established it would be acceptable to establish equivalency around that limit which should be comparable within a range that is declared clearly.
- iii. The general procedures for evaluating equivalence once endorsed shall be presented in the procedural manual as a single document for both qualitative and quantitative methods.
