#### **Procedures for FMDV Inactivation:**

### - (1) Milk and Cream for Human Consumption:

- a) Treated at a minimum temperature of 132°C for at least one second (Ultra-High Temperature [UHT]), or
- b) Treated at a minimum temperature of 72°C for at least 15 seconds, with a pH above 7.0 (High-Temperature Short-Time Pasteurization [HTST]), or Subjected to HTST treatment twice for milk with a pH of 7.0 or higher.

#### Milk for Animal Consumption

- a) Subjected to HTST treatment twice, or
- b) HTST combined with another physical process, such as maintaining a pH of 6 for at least one hour or additional heating to at least 72°C with drying, or
- c) UHT combined with another physical process as specified in (b).

### (2) Meat and Meat Products:

### a) Canning:

Meat in tightly sealed cans, thermally processed until the core temperature reaches at least 70°C for a minimum of 30 minutes

### b) Thorough Cooking:

Deboned and defatted meat heated to a core temperature of at least 70°C for a minimum of 30 minutes, packaged to prevent virus contamination, and necessary precautions taken.

## c) Salting and Drying:

- Meat salted with table salt (NaCl) after rigor mortis, completely dried, with a water-to-protein ratio not exceeding 2.25/1, or defined with a water activity (Aw) of no more than 0.85.

#### - (3) Hides and Skins:

- a) Treated with salt (NaCl) containing 2% sodium carbonate (Na<sub>2</sub>CO<sub>3</sub>) for at least 28 days, or
- b) Semi-processed hides and skins (limed hides, pickled hides, wet blue, and crust leather).

### — <sup>(4)</sup> Wool and Hair:

- a) Industrial washing of wool by immersion in a series of water, soap, and sodium hydroxide (soda) or potassium hydroxide (potash) baths, or
- b) Chemical depilation using slaked lime or sodium sulfide, or
- c) Fumigation with formaldehyde in an airtight chamber for at least 24 hours, or
- d) Industrial washing by immersion in a water-soluble detergent maintained at 60-70°C, or
- e) Storage of wool for four months at 4°C, four weeks at 18°C, or eight days at 37°C.

## - (5) Intestinal Casings:

Treated for at least 30 days with dry salt (NaCl), saturated brine (NaCl, Aw< 0.80), or phosphate-supplemented salt containing 86.5% NaCl, 10.7% Na<sub>2</sub>HPO<sub>4</sub>, and 2.8% Na<sub>3</sub>PO<sub>4</sub> (weight/weight), maintained at a temperature above 12°C throughout this period.

# - <sup>(6)</sup> Pig Bristles:

- a) Boiled for at least one hour, or
- b) Soaked in a 1% aqueous formaldehyde solution for at least 24 hours.

## - (7) Straw and Hay:

Must not be contaminated with animal-origin materials of detectable size and must be treated as follows if transported in bales:

- a) Steam treatment in an enclosed chamber, ensuring a core temperature of at least 80°C for a minimum of 10 minutes, or
- b) Exposure to formalin fumes (gas formaldehyde) from a 35-40% commercial solution for at least 8 hours at a minimum temperature of 19°C.

### - (8) Blood, Meat, Bone, Horn, and Hoof Meal:

Subjected to thermal processing until a core temperature of at least 70°C is reached for a minimum of 30 minutes.

## - (9) Hides and Trophies of Disease-Susceptible Wild Animals:

Before taxidermy processing, one of the following procedures must be applied:

- a) Boiling in water for an appropriate duration to remove all materials except bone, horn, hoof, claw, antler, or tooth, or
- b) Gamma irradiation at a dose of at least 20 kilograms at room temperature (20°C or higher), or
- c) Immersion in a 4% (weight/volume) sodium carbonate (Na<sub>2</sub>CO<sub>3</sub>) solution, maintaining a pH of 11.5 or above for at least 48 hours with agitation, or
- d) Immersion in a formic acid solution (containing 100 kg salt [NaCl] and 12 kg formic acid per 1000 liters of water) at a pH below 3.0 for at least 48 hours with agitation, or
- e) Raw hides treated with salt (NaCl) containing 2% sodium carbonate (Na<sub>2</sub>CO<sub>3</sub>) for at least 28 days.

**NOTE:** Animal products marked with (1), (2), (3), (4), (5), (6), (7), (8), and (9) are subject to import restrictions. However, they may be imported if they undergo one or more of the treatments specified under (1), (2), (3), (4), (5), (6), (7), (8), or (9). The applied treatment(s) must be explicitly stated, and the exporting country's Veterinary Services must certify in the Health Certificate that all necessary precautions have been taken to prevent Foot-and-Mouth Disease virus contamination post-treatment.
